1. Each and every organization requesting use of the Chapter facilities must:
 - A. Obtain permission and reservation from the Chapters designated Representative
 - B. Persons using facilities will have a designated person who will be held accountable for any damage and all trash removal.
2. All handicapped persons shall have an attendee with them at all times.

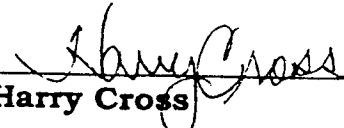
3. NO MEMBER WILL REVEAL TO ANY NONMEMBER THE COMBINATION TO ACCESS THE CHAPTER PROPERTY. THERE WILL BE NO EXCEPTIONS!!!

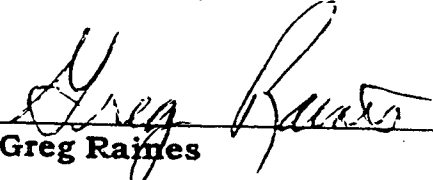
- A. **Any member** who reveals the combination to a nonmember will be brought before the Board of Directors in accordance with ARTICLE I SECTION 3 of the Chapter Bylaws.
 - B. **Any member** who brings a guest must remain with said guest(s) at all times until guest(s) leave Chapter grounds.
 - C. Any member using Clubhouse or Grounds shall be responsible for any damage to building and grounds.
 - D. **ALL MEMBERS** shall be solely responsible for their conduct casting a reflection or embarrassment upon the Chapter. All violators will be brought before the Board of Directors in accordance with ARTICLE I SECTION 3 of Chapter Bylaws.
4. Visiting members of other Chapters shall be extended membership privileges at all times.
 5. Dogs shall not be allowed to run freely and waste must be removed from Chapter Grounds.
 6. All firearms will be handled in accordance with Range Rules and as stated in Laws of the State of Virginia.
 - 7. SWIMMING** IN THE POND IS PROHIBITED.

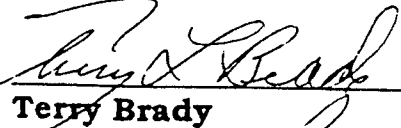
8. The use of gasoline motors on the pond is prohibited.
9. Fishing the pond shall be confined to members and their immediate families, and up to 10 guests. All State Fishing Laws shall be strictly adhered to.
10. Absolutely **NO HUNTING** on Chapter property!
11. **No Bunking** in the Clubhouse.
12. **No Fires** on grounds except in designated areas.
 - A. Grills are permitted at Pavilions proved safety is adhered to.
13. On designated work party days, the Buildings, Pavilions, and Ranges will be **Closed to all activities.**
14. All areas behind Ranges are off limits at all times with exception to being a designated workday.
15. Campers will not use any utilities (electric & water).
16. **Fireworks are prohibited**, except under Chapter Authority.
17. **No ATV's, or Four Wheelers** allowed on Chapter property.

Any deviations to the aforementioned items shall be voted on and granted by the Board of the Directors.
